

## **Instructions for The Inbound Passengers**

- **1-** All passengers have to fill the required form through ( <a href="https://www.visitjordan.gov.jo">https://www.visitjordan.gov.jo</a> ) and get the QR code before the departure then send it to us.
- **2-** Each passenger must fill the health declaration form, and send it to us before the arrival time.
- **3-** Passengers must have a negative PCR test within 72H before the flight time.
- **4-** Another PCR test will be required upon arrival (with a cost of 28 JOD), the payment will be done upon obtaining the QR code (in case if there was any issue with the payment, we can cover it from our side upon arrival).
- **5-** The following to be applied on the vaccinated passengers (who received all doses of the vaccine):
  - Vaccination certificate proves that all doses of vaccine have been received and issued from the following countries (Australia, Bahrain, Canada, China, Liechtenstein, EU, Japan, KSA, Tunis, Kuwait, Malaysia, Morocco, New Zealand, Oman, Qatar, Russia, South Korea, Switzerland, Taiwan, Turkey, UAE, UK & USA) in addition to vaccination certificate issued from Jordan.
  - Vaccination certificate should be in Arabic or English language only.
  - Negative PCR test conducted within 72H prior to scheduled arrival time to Jordan from the first embarking airport.
  - Vaccinated passengers are exempted from conducting PCR test upon arrival.
- **6-** PCR test and QR code are not required for children under 5 years of age.
- **7-** For medical tourism flights (Ambulance Flights) if the nationality of the patient is unrestricted nationality then the patient will enter on the VISA only, but in case if the patient's nationality is restricted, in that case he must visit <a href="https://salamtak.gov.jo/">https://salamtak.gov.jo/</a> and fill the form with the required information.
- **8-** For Non-Jordanian passengers, they must have a travel health insurance.
- **9-** Health insurance is not required for medical tourism patients.
- **10-** Please check the following link for the list of approved laboratories to do the PCR test for passengers arriving from Turkey, Iraq and Egypt: <u>Visit Jordan (gateway2jordan.gov.jo)</u>

- **12-** Diplomats and employees of regional and international organizations (and their dependents and family members holding diplomatic passports, special passports or regular passports) residing in Jordan have a permanent diplomatic QR code that its validity does not expire, and it is possible to return with this code to Jordan for several trips. They will be exempted from:
  - PCR test before departure.
  - PCR test upon arrival.
  - Health insurance.
- 13- International transfer passengers are allowed at Jordanian airports as follows:
  - PCR test required 72 hours prior to the scheduled time of departure.
  - The planned transfer time is not exceeding 10 hours.
- **14-** The following to be applied on passengers coming from India:
  - A. Jordanian passengers and their families (spouse and children):
    - Jordanian passengers who stayed outside India for 14 up to 45 days are subject to 14 days self-quarantine.
    - Jordanian passengers traveling to Jordan from India through transit airport or who spent less than 14 days outside India are requested to sign an indemnity form for institutional quarantine at Amman Airport Hotel for 14 days and pay the required charges for the whole 14 nights with the amount of (55 JD ++) for each night.
  - B. Non-Jordanian passengers who spent less than 45 days outside India are not permitted to enter Jordan.
  - C. Diplomatic passengers are required to coordinate with Ministry of Foreign Affairs and Expatriates and National Center of Security and Crises Management.
- **15-** Each passenger is responsible for the information provided, as for any falsified or incorrect information the passenger will be subject to a fine 10,000 JD to the Jordan government.
- **16-** Passengers traveling out from Jordan can use their PCR test to travel back to Jordan, provided that PCR test is conducted within 120H before the arrival time to Jordan.

## **Notes:**

- \*There is no quarantine required for passengers with a negative PCR result (Article 14 is exempted).
- \*In case of positive result upon arrival, passenger must commit to adhere to a self-quarantine for a period of 7 days and do the PCR test on the seventh day of the self-quarantine at their own expense.
- \*There are no restrictions for the outbound passengers from Jordan.

Please make sure to inform the passengers with the same so we avoid any issue that may happen.
